Before registering, provide an active email and the following files: 1) Passport photo with blue background, 2) Scan of the original Birth Certificate, 3) Scan of the original Family Card, 4) Scan of the original RA/TK Diploma (if any), 5) NISN RA/TK (if any). The procedures for the completeness of the administration of new students based on online at MIN 3 Banda Aceh are carried out by means of prospective new students who are at least 6 years old and follow an initial assessment and document verification to ensure the readiness and completeness of administration before being officially accepted. Validation of the completeness of the administration of new students is seen from student data, parent data, and complete address (zoning). The mechanism for determining new students is based on online based on considerations of age, domicile, completeness of documents, data validation, following initial assessments, and ensuring a student quota per group of 28 people, providing an appeal mechanism, and utilizing Instagram for transparency and effective communication with parents/guardians of students.
